Proposal title: ... Dalmarnock Youth Project Thursday night youth group sessions

Tell us about your proposal - What will be done, who will do it, where will it take place, how long will it run for, how do you know that it is needed?

Dalmarnock youth group initially started in the Legacy Hub under the People's Development Trust. In recent weeks the youth group has lost its venue and the young people their space in the community. The youth staff have fought to keep the youth group going by finding new premises, receiving donations from the local community and developing a constituted group. The youth group currently has no funding at all and all staff give their time voluntarily.

The youth group was started because there was no youth provision within the Dalmarnock area and since then is has gone from strength to strength with at least 20 young people attending each week. The youth group aims to address issues such as food poverty by providing a hot cooked meal to each child each session. We work on skills of daily living which the young people will help to cook their food and set up and clear away after themselves.

The Youth Group is youth focused and they choose what they would like to do each week and the food that is cooked. The young people have a strong connection with art and creativity and we like to take opportunities for this when we can. Team games and sport are always enjoyed too.

The group has been re-homed in Parkhead Nazarene and will be here until we find out if we can be reinstated within the hub again.

The funding would give us the potential to be able to run every Thursday for a year.

We know this project is needed because of the feedback we have received from the community and the parents of the young people who attend. The youth group has nurtured friendships of young people from all parts of Dalmarnock whereas before they may never have met each other, this work is vital in combating territorialism within the area and ensuring the integration process continues within the community.
