FAIR PLAY CALTON

Tell us about your proposal - What will be done, who will do it, where will it take place, how long will it run for, how do you know that it is needed?

WHAT WILL BE DONE

FAIR PLAY CALTON will support access to family friendly events in green spaces, leisure and community facilities. Events such as funfairs and inflatable city on Glasgow Green are just a couple of examples of popular events in the area which we would like to widen access to by supporting entrance fees, equipment hire or other associated costs.

FAIR PLAY CALTON will encourage families and children to engage in active play and activities in our green spaces and other leisure and community facilities, which are popular but often beyond the pocket of many families in the area.

FAIR PLAY CALTON will aim to help relieve the effects of poverty and advance equality of opportunity, by opening up access to activities and experiences which some children in Calton will not have access to otherwise.

WHO WILL DO IT

The Friends of the People's Palace, Winter Gardens & Glasgow Green, along with Calton Area Association will aim to identify activities and experiences, which are currently not accessible to children and families in poverty in Calton due to costs and aim to open up access via support from the fund. The applicants will also liaise with the community and families to identify those to whom such assistance is most needed and learn more about the needs of those families and children so as to best support them.

WHERE WILL IT TAKE PLACE

Activities and experiences for children and families taking place in parks, green spaces, community resources and other facilities which encourage more children to be more active, and give opportunity for more families to spend time together, reducing social isolation and encouraging community integration will be a priority.

HOW LONG WILL IT RUN FOR

It will run from April 2019 - March 31 2020

HOW DO YOU KNOW THAT IT IS NEEDED

We know this is needed as it has been identified as an area of disadvantage and exclusion from talking to families in the area who are unable to fund trips to funfairs and other ticketed events in our parks, green spaces, sporting, community and leisure facilities for which there is either an entrance fee, equipment hire, or other associated costs.

Who in Calton Ward will benefit, and how?

Families and children who may be disadvantaged or excluded from taking part in events and activities in parks, green space and other leisure and community facilities will benefit from removing the main barrier (cost) to access family friendly experiences. Other benefits include increased access to green space, activities and events with a positive impact on physical and mental health and increased social and community cohesion.

This proposal hopes to help level the playing field for those families more likely to experience child poverty such as lone parent households, kinship carers, black and minority ethnic families, young parents, families where a family member is disabled, families with a new baby or with 3 or more children, and families which suffer disadvantage for any reason.
